New Features Included in this Release

This section lists the New Features that are included in this release.

Copy Product Function

Issue Number	Feature Description
MKV5-1903	Added Copy Product option when editing a product. This will allow the user to create a duplicate of the current product and to optionally specify the attributes of the product to copy such as applicable stages, page layout etc.

Portal Document Synchronisation Function

Issue Number	Feature Description
MKV5-2046	In our version 3 product users had the ability to sync produced case documents with the portal system. This update adds this functionality to the version 5 portal system.

Include Version 3 Search Views To Version 5 Release

Issue Number	Feature Description
MKV5-1842	Our older version 3 product had a number of search views accessible via the advanced search. These have now been included in our version 5 product. Although search views are now user configurable we have added these to promote continuity for customer systems that are converted to version 5.



Add Related Products Panel to Insurance Products

Issue Number	Feature Description
MKV5-1963	Some of our early converted customers have helped us identify that the addition of the 'Related Products Panel', which previously only appeared on mortgage products, would make it easier to navigate back to the related mortgage product. This fix has been implemented to add the panel to insurance products.

Retirement age maximum too low

Issue Number	Feature Description
MKV5-2068	This fix increases the retirement age upper limit for applicants to 100 years of age.

Bugs fixed in this release

This section lists identified bugs that have been fixed in this release.

Attachments not appearing against sent email preview (document history)

Issue Number	Feature Description
MKV5-1630	An issue was identified where attachments against previously sent emails would not display when clicking into the email within the document history. This fix displays the attachments and makes them available.

Diary entry type refreshing when saving a diary entry window

Issue Number	Feature Description
MKV5-1876	After filtering the homepage diary entries by a particular type, if a user edits a diary entry and then closes the diary entry edit window, this would revert the filter back to 'All types'. This entry fixes this issue.



Paid date not populating against paid participants on case

Issue Number	Feature Description
MKV5-2020	Fixes an issue that prevented the paid date from displaying in the commissions options panel, against participants who had been paid.

Lenders - ' symbol causes lender drop down box to error

Issue Number	Feature Description
MKV5-2027	Fixes an issue that prevented a user from creating a lender in the addressbook whos descriptive name included an apostrophe.
