## Testing of the Release

Testing for this release was carried out in accordance with the test plans as created by the eKeeper Quality Assurance Team.

### New Features Included in this Release

This section lists the New Features that are included in this release.

#### Bring back the case tracking page

Issue Number	Feature Description
MKV5-2246	This update brings back a highly requested feature from our earlier version.  Users can now enable and access the case tracking page (now known as the 'product tracking page').  This page provides an at-a-glance view of the stage listings and each of the cases due soonest along with some helpful status information regarding the products listed.

#### Preparing for the solution builder integration

Issue Number	Feature Description
MKV5-2338	We have been working on an integration with life sourcing tool <i>solution builder</i> , where you can quote for life, income protection, family income benefit and more.  This update contains some behind the scenes changes in preparation for the go live date for the integration. A future update will make the integration live and users will be able to utilise it from then.

#### Added JavaScript Upload feature for the fact-find

Issue Number	Feature Description
MKV5-2530	We've added a feature that was present in our older version. You can now upload custom JavaScript files to the fact-find. These will be executed (post security check) upon entering each fact-find page.

### Bugs fixed in this release

# Document warning displaying against HTML documents even through they were accessible

Issue Number	Feature Description
MKV5-1028	We've fixed an issue that meant that HTML document template would always display the yellow warning triangle indicating the file was inaccessible, even though the file was accessible. Now the triangle will only appear if the file is physically inaccessible.

#### Deleted prerequisite rules still asking to be fulfilled

Issue Number	Feature Description
MKV5-1513	When deleting a prerequisite for a stage relating to simple tasks the system was still trying to force users to complete the prerequisites before moving on. We've fixed this so that if a user requests to delete a prerequisite, the process checking for the prerequisite being fulfilled is also deleted and users will no longer be prompted to complete them.

#### Product specific merge-fields not working as expected

Issue Number	Feature Description
MKV5-2310	This fixes an issue that meant if you were producing a letter on a product, if that letter does not include product specific merge fields for the product it was produced from, then the applicant generic merge fields would not work.

#### Case reference number not generating on new cases

Issue Number	Feature Description
MKV5-2388	This fixes an issue that meant new cases were not obtaining reference numbers and would display 'not specified' at the top of the case.

# White screen displaying when producing a spreadsheet document

Issue Number	Feature Description
MKV5-2395	Some users were experiencing a white screen when producing a spreadsheet document. This has been fixed so that spreadsheets will now produce as expected.

#### User roles not populating onto new insurance products

Issue Number	Feature Description
MKV5-2464	If a user has a user role set against them, for example Adviser, Administrator etc. Then when that user creates a new insurance product the system was not adding them to the product as the adviser, administrator etc. This has now been fixed so that newly created insurance products

# Selecting customer custom fields as criteria on reports causes an error

Issue Number	Feature Description
MKV5-2531	If you choose a customer custom field option as the criterion for your report, the system was throwing an error. We've fixed this, no more errors here!

### Initial Enquiry Statuses - Missing mouse cursor on hover

Issue Number	Feature Description
MKV5-2643	Fixes an issue that caused the mouse to disappear when hovering over the edit link in System Settings > Initial Enquiry Statuses
