## Introduction

These software release notes cover all system modifications for version MKv5 6.19.0 of the eKeeper CRM system.

The release notes list the bug fixes and known issues provided in this release and are aimed at operational users of the system. These release notes do not aim to go into technical detail about specific changes or to be the basis for system testing plans.

## Testing of the Release

Testing for this release was carried out in accordance with the test plans as created by the eKeeper Quality Assurance Team.

#### New Features Included in this Release

This section lists the New Features that are included in this release.

Added collapse by default setting for attached files

Issue Number	Feature Description
MKV5-2358	Users can now request to change whether the attached file categories are collapsed by default within the attached files panel on the case.

## Bugs fixed in this release

This section lists identified bugs that have been fixed in this release.

Output of some search view fields display as numbers instead of the appropriate value

Issue Number	Feature Description
MKV5-2274	Some users experienced a display issue when using custom search views. This meant that the search results would sometime display numbers rather than the appropriate value for that particular field. All custom search views now output the correct values when using them to display search results.

Inactive simple tasks appearing against newly created products

Issue Number	Feature Description
MKV5-2309	When making a simple task inactive, the task was previously appearing on newly created products.  Inactive simple tasks now appear on existing products, if used, and newly created products will no longer display them.

New email templates defaulting recipients as all companies

Issue Number	Feature Description
MKV5-2330	New email templates will no longer default the recipient as all companies, this has now been changed to default to all applicants instead.

### Unable to link a fact-find question to a field in the system

Issue Number	Feature Description
MKV5-2365	When creating or editing a fact-find question it is now possible to save it as a linked question to another field elsewhere in the system.

Missing dropdown options when trying to copy a set of fact-find answers to a new product

Issue Number	Feature Description
MKV5-2407	When entering the fact-find on a new product for the first time, the system now displays a list of existing fact-finds as options correctly in the <b>copy an existing fact-find</b> dropdown field.

#### Unable to enable a fact-find subset in the portal system

Issue Number	Feature Description
MKV5-2410	Some conditions were preventing users from submitting fact-finds to the portal system. The system would then open the print fact-find page inexplicably. This has now been resolved so that user can submit the fact-find to the portal and the print fact-find functionality does not appear.

### Print fact find failing the first time it is used

Issue Number	Feature Description
MKV5-2429	Fixed an issue that caused the print fact-find mechanism to fail the first time a user accesses it.
